FLIGHT SYSTEM

If the number of competitors in a category warrants it, a flight system will be used.

WARM UP GROUPS

As per Skate Canada Competitions rule 3.2, the sub-groups within a warm-up group draw will be used for subsequent starting order draws.

CANCELLATION / ADJUSTMENT OF EVENT

Skate Canada: Alberta-NWT/Nunavut reserves the right to cancel the event.

Skate Canada: Alberta-NWT/Nunavut continues to monitor the COVID-19 pandemic. If any adjustments may be required to the event for the health and safety of all members, a communication will be issued to all those who have registered for the event, as well as communicated on the Section website.

ENTRIES – ELIGIBILITY

Entrants shall be:

- Eligible persons as defined in Skate Canada Rule Book > Competitions > 2.1
- Be registrants in good standing of the Association.

RESTRICTIONS OF ENTRIES

If necessary, entries may be limited to adhere to the Section Guidelines for hours of competition. Skaters entering multiple events do so with the understanding that there may be conflicts that cannot be resolved.

DEADLINE DATES

CLOSING DATE OF ENTRIES

All entries must be received no later than **September 8, 2021, at 12:00pm (noon) MT**. It is the responsibility of the competitor to ensure that their entry is submitted by the closing date, at their own expense. All assessment requirements must be passed by the closing date of entries.

LATE ENTRIES

Late entries may be accepted at the discretion of the Technical Representative and if space permits in the event. Entries received after the deadline date will have a late entry fee of \$100 applied per entry. Late entries may be accepted up till **September 10, 2021, at 12:00pm (noon) MT**.

No entries will be accepted beyond the late registration deadline date, no exceptions.

REFUND OF ENTRY FEES

Entry fees shall be refunded only if the event is not held or if the entry is withdrawn before the date of close of entries (Skate Canada Rule Book > Competitions > 1.3). There will be a **\$10.00** administration fee applied to all refunds.

After the closing date of entry (September 8, 2021, at 12:00pm (noon) MT) there will be no refunds given for any reason, including medical pulls. No exceptions.

REGISTRATION REQUIREMENTS

HOW TO REGISTER

- All registrations must be completed using the Uplifter online registration form.
- Refer to the [How to Register](#) link on the Skate Alberta-NWT/Nunavut registration site for detailed instructions.
- All payments must be paid online using a credit card at the time of registration.
- Program Music (in MP3 format) See page 9 for complete music submission details. Ensure the correct version of music is being uploaded.
- The Skate Canada Waiver must be signed and uploaded with the registration.

REGISTRATION CHANGES

Confirm which event to register in with your coach before submitting your registration. No category changes or skater information changes will be accepted after **September 15, 2021**.

PROOF OF AGE

For all categories, age shall be the age of the skater before **July 1, 2021**. You do not have to submit your proof of age document when registering. While proof of age is not required at the event, the competitor is expected to abide by the age requirements and register in the appropriate category. It is the coaches responsibility to ensure the skater is entered in the correct category according to Skate Canada's age and test requirements.

PLANNED PROGRAM SHEETS

Planned Program Sheets are required for each entry. Planned Program Sheets must be submitted by **September 22, 2021, at 12:00pm (noon) MT**.

There will be a \$20 fee for failing to register Planned Program Sheets by the deadline. **Planned Program Sheets will not be accepted onsite and must be completed via the Uplifter link.**

Planned programs will be submitted through Uplifter. See "How to Submit a Planned Program" link on the registration page for assistance in completing your planned program content sheet.

ONSITE REGISTRATION

All competitors and coaches must enter the building at their assigned arrival time. Specific information regarding the on-site registration process will be sent out to skaters and coaches one week prior to the event. Coaches will be requested to email their signed Skate Canada Waiver prior to the event.

PRACTICE ICE

Practice ice will be made available for purchase after the close of registration.

COACH ACCREDITATION

All coaches must be minimally NCCP Regional Coach in Training and carry proof of current membership within the Association and a valid First Aid certificate. Coaches will be required to register at the registration desk. **A maximum of (1) one coach will be allowed at ice level as determined by the skater/team.**

SPECTATORS/PARENTS

Two (2) individuals (spectator/parent) will be allowed in the stands for their skaters' performance. No spectators/parents will be permitted at ice level or in the dressing rooms. Physical distancing of two metres is required in the stands unless you are from the same household. Face coverings are not required; however, they are recommended. Spectators/parents will be asked to leave the facility once their skater is finished, as there is no loitering permitted in the facility before, after or in between ice times. Please see the Arena Spectator Rules posted throughout the venue for more information.

Should a skater be unable to register themselves on-site, a Parent/Adult will be admitted into the facility to assist in the registration process for no longer than 15 minutes.

CAMERA POLICY

Flash photography is not permitted. Persons wishing to take photographs of on ice performances are reminded that use of flash cameras is forbidden. The use of video cameras must be restricted to areas that do not hamper the skaters or officials. You may only take pictures or videos of your own skater.

MUSIC SUBMISSION REQUIREMENTS

Music Registration

- a. Online music registration will require each skater or team to submit an mp3 file of their program music and the music time online at the time of their registration. **This includes music for pattern dances.**
- b. Music files will not be kept so skaters and teams will be required to submit their music for each individual competition.
- c. Each skater or team will be required to carry a copy of their music on CD and must have it readily available at rink-side as a backup. Cell phones, iPods, and other personal devices will not be accepted.
- d. If there have been changes to the music after the submission during the online registration, the updated music file must be uploaded by **September 22, 2021**. New music can be re-uploaded through your Uplifter account.

Labelling

Skaters or team's first and last name(s), category name, total music time (not skating time) and home club shall be clearly printed:

- a. Identify the CD by writing on the front of the CD using a permanent marker.
- b. DO NOT write on the recorded side of CD
- c. Label the back of the CD case. Do not apply stick on labels to the CD.

Recording Specifications

- d. The only format for online upload of music will be mp3.
- e. Only one program (using one track only) shall be recorded on each CD.
- f. Music shall be recorded on the CD not less than .25 second and not more than .5 second after the play button is pressed on the CD player.

All music used must be in the public domain or covered by the performing rights societies.

Competitors who have music composed specifically for their programs either wholly or in part, are responsible for obtaining a written release from the composer for the use of such music on radio and/or television or appropriate clearance from the performing rights societies.

MEDALS

Medals will be presented on-site. To minimize large gatherings, medal presentations will be limited to the following in attendance: one coach per medallist and up to two (2) spectators per medallist. In the case of only one entry in an event, an exhibition shall be performed but no medal shall be awarded.

JUDGING SYSTEM

The Cumulative Points Calculation (CPC) Judging System will be used for all event categories.

PROTEST POLICY

Skate Canada Protest Policy for competitions using CPC will be followed. If there is an event using manual calculation where the results are not posted within one hour of the completion of the last event of the day, the protest must be made to the Event Referee within the first hour of the following day's competition. If the Event Referee is unavailable, the protest may be made to the Technical Representative or Chief Referee.

ACCIDENTS / LIABILITY

Skate Canada: Alberta-NWT/Nunavut Section, Skate Canada and the volunteer team undertake no responsibility for damages or injuries suffered by skaters. As a condition of and in consideration of their entries in this event, all competitors and their parents/guardians shall be deemed to agree to assume all risks or injuries to the competitor's person and property resulting from, or caused by or connected with, the conduct and management of the competitions and to release any and all claims they may have against the officials, the association, the Section, Skate Canada, the volunteer team and against their officers and their entries shall be accepted only on these conditions.

ANTI-DOPING POLICY AND DOPING CONTROL POLICY

Agree to be subject to Association rules and regulations regarding doping controls, on an announced or unannounced basis, as determined by the Board of Directors from time to time. Such rules and regulations shall be entitled "Skate Canada Anti-Doping Policy and Doping Control Program" and shall be made available to potential entrants upon request to their Section or the National Office. The event may be live streamed. By virtue of your registration for the event, you are consenting to being included in the live streaming of this event. By attending and competing at the competition, you waive any right to inspect or approve any video or audio recordings taken by Skate Canada: Alberta-NWT/Nunavut.
