


# STARSkate CAMP with Kaetlyn Osmond!!

## **STARSkate Camp Participant Vaccination Requirements**

Children 0-11 years of age will not be required to show proof of vaccination, or a negative COVID-19 test but have to screen for symptoms

Youth age 12 to 17 years of age are required to show proof of Vaccination, negative test, medical exemption plus valid personal identification to enter the building. This could be a birth certificate, health care card, student id card, or other government-issued identification

Adults age 18 & older will be required to show proof of Vaccination, medical exemption plus valid personal identification to enter the building. Workshop registrants age 18 & older may provide proof of negative test however they are required to submit their name to the Section in advance of the workshop. Anyone who does not have the proper documentation or is not on the list will not be permitted to enter the facility if they are unvaccinated.

#### Tests must be:

- 1. Provided as an original or printed copy (photos are not sufficient)
- 2. Privately paid
- 3. A Health Canada approved rapid antigen, rapid PCR, or lab-based PCR test
- 4. Completed within the past 72 hours of when they are entering the facility
- 5. Test results must show the type of test, time of sample collection, clear indication of a negative result, and laboratory that completed the test.
- 6. Tests must not be from Alberta Health Services or Alberta Precision Laboratories.

As per Alberta Health's requirements Rapid Test Kits that are available for free for at-home use cannot be used for the Restrictions Exemption Program. Unvaccinated people must pay to obtain proof of negative test results through a private vendor or pharmacy to gain entry
