The Chair thanked everyone for their participation in the recent Skate Canada Ice Summit and Annual General Meeting. 9. PROPOSED AMENDMENTS TO ASSOCIATION BYLAWS

Alison Bonney – Gregson, Chair of the Governance Committee presented an update about the Association Bylaws.

In February 2024 a request for proposed amendments to the Bylaws was advertised to the Membership. As per Article 12, any member of Section may have submitted bylaw proposals, amendments, or repeals in writing to the Executive Director a minimum of ninety 90 days in advance of the Annual General Meeting at which they are to be considered. Additionally, and as per Article 12, Section members had until 52 days prior to the Annual General Meeting to respond, via written submission to the Executive Director of the Section, to any such proposed amendments.

There were no submissions received to the Executive Director, and the Section's Governance Committee also did not have any proposed amendments to bring forward at this time.

Alison provided an overview of some of the changes that were recently made to the Skate Canada Bylaws to be inline with the Canadian Sport Governance Code. The Section's Governance Committee will be reviewing the Section Bylaws in the coming months to proactively align with the Canadian Sport Governance Code and best practices, with the intention of bringing forward proposed amendments to the membership for consideration at a Special Meeting to be held in the Fall.
